3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Routine monitoring samples taken on 12th February 2026 recorded:

- Ammoniacal nitrogen as N at 46.6 mg/l. The permit limit is 11 mg/l.
- BOD at 128 mg/l. The permit limit is 40 mg/l.
- Suspended Solids at 81 mg/l. The permit limit is 60 mg/l.

These sample results are all breaches of the permit. However, the plant had only recently been turned back on after a down period, during which all effluent was being tankered from the site. This allowed a significant refurbishment and upgrade to the plant to be implemented. It is understood that the plant may subsequently take up to six weeks to get fully up to speed and achieve full treatment.

Action: Sample again in six weeks time. If the discharge remains non-compliant, investigate the reasons for this and make any improvements required to regain regulatory compliance. Report back any findings to NRW.
