## 4. Details of our assessment

On the 1st of September 2025 Ammonia was recorded at 27.06mg/l against the regulations limit of 25mg/l.

This site benefits from the look up table procedure which allows a number of exceedances before and absolute failure is recorded. This result has been recorded as an exceedance.

On the 1st of September 2025 BOD was recorded at 126mg/l against the regulations limit of 45mg/l.

This is the 3th exceedance for BOD at this site within the last 12 month period. Based on the LuT and the site's sampling frequency, this result is classed as a LuT failure.
