Introduction

This Compliance Assessment Report is a review of the Valero Pembrokehire Oil Terminal compliance and reporting submissions for 2025.

Point Source Emissions to Water (Water 1 Form)

The annual submission (submitted in part monthly, throughout the year) included results for all parameters required over the annual reporting period. The reported values are in compliance with the limits outlined in Schedule 3 of the permit.

Annual Water and Energy Use

The annual water use/energy use data specified by the permit were also received and include the reporting parameters specified by Schedule 4 of the permit.

Note: This CAR report and assessment was undertaken on 23 February 2026. However to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS system has been altered to 31 December 2025.
