### 4. Details of our assessment

This Compliance Assessment Report accompanies the attached Operator Monitoring Assessment (OMA) for discharges to water carried out at the site on 11 December 2025.

The overall score for the site was 114/135 (85%), no non-conformances with the permit were observed during the audit.

The operator has a mature and well-integrated management system for monitoring, and the sampling and analysis is consistent with the requirements of the permit and other recognised standards.

Areas of potential improvement are identified for each OMA topic area.
