Natural Resources Wales officers Shaun Rees and Kirsty Allwood met with the site representatives to carry out a routine audit of the site on the 18 February 2026 at 10:40.

A walk around the site was not permitted, as the site representatives were concerned with Avian Influenza, so not all part of the permit were inspected.
