4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter *NRW*) assessment against RF Brookes Ltd. Permit Number UP3237CP annual monitoring and reporting requirements. NRW's assessment of RF Brookes (UP3237CP) Ltd. monitoring returns data is outside the scope of this CAR and any non-compliance arising from an exceedance of a permitted emission limit will be recorded in a separate CAR.

Condition 4.2.1 of the environmental permit states:

4.2.1 The operator shall send all reports and notifications required by the permit to Natural Resources Wales using the contact details supplied in writing by Natural Resources Wales.

4.2.2 A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

(a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;

(b) the annual production / treatment data set out in schedule 4 table S4.2; and

(c) the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.

4.2.3 Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

(a) in respect of the parameters and emission points specified in schedule 4 table S4.1

(b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.4 ; and Permit Number EPR/UP3237CP 7 Issued: 25/03/2022

(c) giving the information from such results and assessments as may be required by the forms specified in those tables

Report(s) for condition 4.2.1 were submitted via email on 27/01/2026. This was within the 28 day reporting deadline.

The report(s) submitted for emissions to air, water and sewer are the parameters and the emission points specified in Tables S3.1 to S3.3 Schedule 3 which represents compliance with the environmental permit.

The report(s) submitted are for the reporting periods specified in Tables 4.1 to 4.4 in Schedule 4 which represents compliance with the environmental permit.

For action

While all levels were below emission limit values, it was noted that oxides of nitrogen (NO

and NO₂ expressed as NO₂) at Emission Point A10 had a result of 93.93 mg³ which is very close to the emission limit value of 95 mg/ m³. Please bear this in mind to avoid this emission limit value being breached in the future.
