## 4. Details of our assessment

Routine site inspection of Raglan Wastewater Treatment Works carried out by Environment Officer Peter Jones. Weather over cast and heavy showers.

### Observations

The inlet screen was clean, inlet flow was exceeding the flow passed forward and spilling to storm. The Storm tank looked to be almost full.

The EDM monitor was clearly labelled. The EDM maintenance is next due 12/28

From the inlet the effluent flows to a single skin steel activated sludge tank. The return activated sludge (RAS) was operating during the inspection. The flow channels are clear and the effluent is flowing freely.

The humus tank was well maintained and was operating as designed. Sludge from the wedge wires is washed back into a holding sump which is then returned to the aeration tank.

The final effluent and UWWT sampling points are clearly labelled. The final effluent was clear at the time of the inspection.

The site diary was up to date.

There are no follow up actions to be completed following this site inspection.
