4. Details of our assessment

This Compliance Appraisal Report (CAR) Form has been prepared to assess the annual returns for 2025 which were required to be submitted to NRW by 31st January, in association with permit condition 4.2.2, and CAR_NRW0046432, issued on 25/02/2025. The annual monitoring returns were submitted to NRW on 23rd January 2026.

Animal feed production in 2025 has been reported as 321,318.6 tonnes, which is a little lower than 2024 - 348,885.32 tonnes.

Reporting of emissions to air

Annual emissions testing (total particulates matter) was carried out on emission points A12, A14, A15 and A16 on 26th & 27th November 2025 by an MCERTS-accredited third party monitoring organisation.

Values were recorded as follows: A12 - 0.53 mg/m³; A14 - 0.66 mg/m³; A15 - 1.70 mg/m³; A16 - 12.20 mg/m³. The permitted limit for each stack is 20mg/m³, so you are compliant with your permit at this time.

Reporting of Energy Usage

Energy usage in 2025 was reported as 20150.97 MWh, which is slightly lower than usage in 2024 (20750.18 MWh). CO₂ emissions were reported as 3675.70 tonnes in 2025, compared to 3765.6 tonnes in 2024.

Reporting of water Usage

The quantity of water used in 2025 was 0.0712 m³/tonne of feed produced, which is slightly higher than in 2024 (0.0686 m³/tonne)

Waste disposal and recovery

The quantity of waste which was disposed of in 2025 is recorded as 234.691 tonnes, slightly higher than in 2024 - 205.63 tonnes.
