4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Regulating Natural Resources Wales (NRW) officer to comment upon the Annual Report and Q4 Monitoring Returns.

Q4 Monitoring Returns

Q4 2025 (October - December) monitoring results were submitted to NRW on 13/01/26 in accordance with Condition 4.2.3.

Emissions to Water - Emission Point W1

Emissions were tested for Flow, pH, Suspended Solids, Chemical Oxygen Demand, Iron, Chromium, Mercury, Nickel and Zinc. Noted that all measured parameters are below permitted emission limit values (ELV).

Annual Report

Emissions to Air

Combustion plant reporting emissions for the period 01/01/25 - 31/12/25, were reported as follows:

- Emission points A1, A2, A3 and A4 gas and oil firing conditions and A5, A6 and A7 oil firing conditions only, were NOT OPERATED, therefore no results reported.
- Emission point A8 was not operated due to maintenance.
- Emission points A5, A6 and A7 gas firing conditions only, were monitored for oxides

of nitrogen as NO₂ and carbon monoxide (CO) on the 05/11/2025. All recorded emissions were below the ELVs.

Galvanising line reporting emission points were monitored for NO₂ and CO for the period 01/01/25 - 31/12/25 and were reported as follows:

- Emission points A31, A32, A33 were NOT OPERATED.
- Emission points A35, Galvanising Furnace No.6 reported data did not raise any issues.

Regenerative Thermal Oxidiser (RTO) line emission points were monitored for NO₂, CO and Volatile Organic Carbon (VOC) for the period 01/01/25 - 31/12/25 and were reported as follows:

- Emission point A12 was NOT OPERATED.
- Emission point A12A, A18 (COBRA) and A21 all recorded emissions were below the ELVs. Emission points A13, A14 and A15 reported data did not raise any issues.

Fugitive Emissions

Fugitive solvent emissions calculated for Colour Coat lines 2 and 1 fell from those reported for 2024 (3.16%) with average emissions for 2025 being 2.57%.

Performance Parameters

Annual Energy consumption has increased very slightly in comparison to 2024 reported data. Potable water use has also increased slightly and non-potable water use decreased in comparison to the 2024 report. There is a slight increase in non-hazardous waste production for 2025 and a reduction in hazardous waste quantities. No notable changes in other parameters recorded.
