4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) regulating officer to comment upon the annual monitoring data and annual report for the regulated facility.

The annual monitoring data and annual report were submitted to NRW on the 25 February 2026. The late submission is **a breach of Condition 4.2.3 and has been scored C4, see Action 1 below.**

Annual Monitoring Data

Air Emissions - Emission Point A2

Annual air monitoring was undertaken on the 7 October 2025. Air emissions monitored for particulate matter (PM), lead (Pb) and volatile organic compounds (VOCs) were reviewed and all emissions were reported to be below permitted ELVs.

Emissions to Sewer - Monitoring Point S1

Annual sewer sampling and monitoring was undertaken on 15 May 2025 and 21 October 2025.

Sewer discharges analysed for Pb and chemical oxygen demand (COD) were reviewed and all emissions were reported to be below permitted ELVs.

Annual Report

Energy (E1) and Waste (R1) data has been submitted by the Operator for 2025.

Historically, this was provided for the Lead Line only. The submitted for 2025 is for the Installation as whole and a direct comparison to previous submissions cannot be made.

The Operator has reported a number of energy reduction projects which have been implemented at the site.

Environment Management System

During September 2025, a third-party audit body, RINA undertook a surveillance audit to ISO 14001:2015 Environmental Management System and ISO 45001:2018 OHSMS. Both certificates were retained.
