### 4. Details of our assessment

This compliance assessment report has been generated for the review of the 2025 annual monitoring returns, Q4 monitoring returns and Q4 waste returns which have been submitted to NRW to satisfy conditions for permit BR9383ID.

#### **Annual Report**

The annual report was submitted to NRW on the 30<sup>th</sup> January 2026 in accordance with permit condition 4.2.2.

A review of annual monitoring returns discussed an permitted emission limit value exceedance which occurred for chlorides as HCl at emission point A on the 15<sup>th</sup> January 2025 with a value of 17.2 mg/m<sup>3</sup> compared to the permitted emission value of 10 mg/m<sup>3</sup>.

A permitted emission limit value exceedance for ammonia at emission point G on the 16<sup>th</sup> January 2025 with a value of 20.6 mg/m<sup>3</sup> compared to the permitted emission limit value of 10 mg/m<sup>3</sup>.

These exceedances was discussed with scores applied in compliance assessment report CAR\_NRW0048161.

A further permitted emission limit value exceedance for ammonia at emission point G on the 12<sup>th</sup> May 2025 with a value of 23.3 mg/m<sup>3</sup> compared to the permitted emission limit value of 10 mg/m<sup>3</sup>.

This exceedance was discussed with scores applied in compliance assessment report CAR\_NRW0048988.

#### **Q4 (October – December) Monitoring Returns**

The Q4 monitoring returns were received on the 22<sup>nd</sup> of January in accordance with permit condition 4.2.3. No permitted emission limit value exceedances were noted during this period.

#### **Q4 Waste Returns**

The Q4 Waste Returns (September to December 2025) were received via email on the 28<sup>th</sup> January

2026 as required by permit condition 4.2.5.

The returns show that the installation is still receiving waste code 101103 – Waste glass-based fibrous materials which is not included in Table S2.2. The operator has now submitted a variation to add the waste code to the permit, a suspended category 4 score has been applied.

**A suspended category 4 score has been applied under subheading IR2A, against permit condition 2.3.3.**
