## 4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) to comment upon the Q4 Monitoring Returns and the 2025 Annual Report.

### **1. Q4 Monitoring Returns**

Q4 2025 (October - December) monitoring results were submitted to NRW on 22 January 2026 in accordance with Condition 4.2.3.

#### **1.1 Air Emissions - Emission Point A1**

Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.2.

No Half Hourly or Daily Average Environmental Limit Values (ELVs) for Hydrogen Chloride, Ammonia, Total Organic Carbon, Oxides of Nitrogen, Sulphur Dioxide, Nitrous Oxide and Particulates were exceeded during Q4 in accordance with Condition 3.2.1.

Emissions to air (Emission Point A1) for Carbon Monoxide show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.2.1.

Daily averages were not available due to the plant being shutdown to clean the final Economiser from 14 to 18 December 2025.

#### **1.2 Residues**

Residues Bottom Ash and Air Pollution Control residues sampling was undertaken in accordance with Condition 3.6.1. Bottom Ash composition for Q4 remained below the 3% TOC limit at 2.03% in accordance with Table S3.4 of the Permit.

#### **1.4 Performance**

Plant operating hours for Q4 (1 October to 31 December 2025) were recorded as 2101, with no periods of abnormal operations.

**1.5 Waste Returns.**

Waste returns have been provided for Q4 as follows:

Waste Received Q4 – 55,821 tonnes.

Waste Removed Q4 – 12,926 tonnes.

**2. Annual Report**

The Annual Report was submitted to NRW via email on 27/01/2026 as required by Permit Condition 4.2.2.

**2.1 Performance**

7,667 Operating hours were recorded between 01/01/2025 and 31/12/2025 with no abnormal operations recorded.

The facility annual maintenance outage was completed between the 11 June and 2 July 2024.

**2.2 Residues**

All IBA generated in 2025 was transported to a suitably permitted receiving and processing facility. Samples of IBA are analysed monthly on randomly selected dates to assess the hazard status in accordance with ESA Protocol. One exceedance of hazardous thresholds was reported in August 2025 due to a combination of high lead and copper.

APC residues continue to be transported to a waste recovery operation facility.

**2.3 Water and Other Raw Materials Usage**

Annual water and raw material usage is reported in accordance with Condition 4.2.2 and shows no significant increases.

**2.4 Waste Returns**

Annual waste data reported in accordance with Condition 4.2.5 shows a slight drop in waste received and removed compared to 2024.

Waste Received - Overall tonnage for the year – 197,883 tonnes.

Waste Removed - Overall tonnage for the year – 50,345 tonnes

**2.5 Emissions to Water**

No specific events to report following weekly monitoring. All discharges free of any visible solids, oils or greases.

**2.6 Annual Energy Usage and Efficiency**

Annual energy usage reported in accordance with Condition 4.2, shows no significant increases.

Indicative R1 Calculation states 0.68, based on 85% Boiler efficiency +/- 3.2%, which meets the minimum criteria (0.60) for R1 status.

**2.7 Air Emissions**

Stack emissions monitoring and testing was undertaken during Q2 and Q3 in accordance with Condition 3.6.1.
