Purpose of assessment

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment of landfill infrastructure construction proposals submitted by the Operator.

Regulatory Context

This assessment has been conducted in response to the Operator submitting relevant construction proposals for landfill infrastructure - namely the the retro drilling of six 160mm gas wells at the site.

On 18 February 2026, the Operator submitted to NRW the landfill infrastructure construction proposals - '*Docksway Well Drilling CQA Plan R0 Infnis February 2026*'.
