4. Details of our assessment

This was an unannounced, site visit made by Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the Standard Rules Environmental Permit (EPR-DB3593FH).

There was very heavy rainfall during the visit.

Previous inspection:

This is the first site inspection for this site as it is a newly issued permit.

Permit Breaches:

No permit breaches were recorded during this inspection.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

General observations:

The site was generally clean and well organised with good segregation of waste types and good waste storage practices were observed. Despite heavy rainfall, the site did not suffer from pooling water and was clear and tidy. All specified waste sections were kept separate. The incoming waste stream is currently relatively low, however is open to expansion. The NRW website is available for information on relevant opportunities such as waste exemptions that can be utilized.

EMS:

The EMS (Environmental Management System) is a structured document manual that helps organisations manage, measure and improve their environmental impact. The EMS is dealt with by TCM Amy Harries who was off on maternity leave, so the EMS will be reviewed at our new inspection visit. Please ensure that your EMS complies fully with your permit requirements. Please also include where possible a procedure on what is done if waste brought to site does not meet your acceptance criteria, including a procedure on what is done if the waste is deemed Hazardous.

Waste Returns:

The operator is required to submit quarterly waste returns. Waste return compliance will be reviewed during our next inspection.

Technical competence:

The site TCM is Amy Harries who was off on maternity leave. She was available if required however, as lives near adjacent to the site. Her current WAMITAB certificate is valid until 09/1/2027.
