4. Details of our assessment

This was an unannounced site visit made by Alex Underhill of Natural Resources Wales (NRW). The purpose of the inspection was to assess compliance against the Standard Rules Environmental Permit (EPR-KB3731AX).

The weather was clear but recent heavy rain had been noted.

Previous inspection:

No permit breaches were recorded during the previous inspection. See CAR_NRW0044244 for the previous inspection.

Permit Breaches:

No permit breaches were recorded during this inspection.

General Management (W1A):

The site is required to be operated in accordance with a written management system that identifies and minimises risks of pollution.

General observations:

The site was generally clean and well organised with good segregation of waste types and good waste storage practices were observed. Despite recent heavy rainfall, the site did not suffer from pooling water and was clear and tidy. The main construction area where waste is stored appears free of contaminants and well structured.

There is another permit held, EPR-HB3836AE. This is intended to be surrendered, with a previous surrender application being submitted. Having spoken with the Permitting department, they have confirmed the previous surrender application was returned, and therefore a new surrender application needs to be submitted, including the additional details requested by the Permitting department when the previous surrender application was returned.

EMS:

The EMS (Environmental Management System) is a structured document manual that helps organisations manage, measure and improve their environmental impact. TCM Daniel Mason is currently in the process of creating the site EMS. Please ensure that your EMS created complies fully with your permit requirements. Please also include a procedure on what is done if waste brought to site does not meet your acceptance criteria, including a

procedure on what is done if the waste is deemed Hazardous. Your EMS compliance will be reviewed during our next inspection.

Waste Returns:

The operator is required to submit quarterly waste returns, within one month of the end of each quarter. Waste return compliance will be reviewed during our next inspection.

Technical competence:

The permit states that the operator shall comply with the requirements of an approved competence scheme. The assigned TCM is Kim Evans. Continued competence evidence will be reviewed during our next inspection.
