**4. Details of our assessment**

On 20th February 2026 Angharad Clark visited site and discussed drainage and the permit with the site operator.

**Site Drainage**

The site drainage map has been provided to NRW which shows that the surface water run off is discharged to a foul sewer pumping station via an interceptor. The operator stated that sampling will be undertaken to submit to Dwr Cymru Welsh Water so that a decision can be made by DCWW as to whether a Trade Effluent Discharge Consent is required. A date for either a Trade Effluent Discharge or proof that a Trade Effluent Discharge Consent is not required to be provided to NRW was agreed as six weeks from the inspection. As agreed, a notice reflecting this date will be issued. Please contact NRW before this date if you are unable to provide this information within the agreed time period.

**The Permit**

The operator queried whether they could use their granulator under their current permit. I can confirm that granulation is included as an acceptable form of treatment under the current permit.

I can also confirm that discharge to a foul sewer is also allowed under the existing permit, providing a Trade Effluent Discharge Consent or proof that one is not required is submitted to NRW.

**Other observations**

The site was segregated with very little stockpiling of scrap evident. The inspection was undertaken during a period of heavy rainfall and whilst there were a few puddles, site drainage appeared to be functioning as designed.
