4. Details of our assessment

Standard Operating Procedure (SOP) revision

Following submission of the revised Standard Operating Procedures – Green Waste Composting (Issue No. 9.2, dated 19/12/2025) on the 17/02/2026 by the operator Cwm Environmental of Nantycaws HCI Waste Transfer & Treatment Facility (permit number EP3698FL), Natural Resources Wales has completed its review.

NRW confirms that the revised Composting SOP is satisfactory and is therefore accepted as part of the site's environmental management system documentation and must be implemented accordingly.

However, we would suggest that future revisions provide further detail on storage and stockpile controls. The Composting SOP sets maximum tonnages but does not describe how tonnage control is monitored daily, actions if storage approaches limits and contingency when inputs exceed processing capacity. A daily storage log with threshold warnings would improve stockpile controls for example "If feedstock exceeds 80% of permitted storage, then X action must be taken". The operator should also include references to estimated volumes where tonnages are referred to.

Please note that the Composting SOP must be maintained as a live document. Any future revisions must be communicated to NRW in line with permit conditions and compliance with the Composting SOP will be assessed during future regulatory inspections.

Fire Prevention Management Plan (FPMP) revision

Following submission of the revised Fire Prevention Management Plan (7a CWM Env – HWRC and Compost FIRE PREVENTION PLAN Nov2025 v.17) on the 17/02/2026 by the operator Cwm Environmental of Nantycaws HCI Waste Transfer & Treatment Facility (permit number EP3698FL), Natural Resources Wales has completed its review.

The plan was assessed against the current NRW guidance *Fire Prevention and Mitigation Plans*, with consideration of on-site storage volumes, waste types, separation distances, detection, suppression, site layout, water availability and contingency arrangements.

NRW confirms that the revised FPMP has been written in line with the guidance and is therefore accepted as part of the site's environmental management system documentation and must be implemented accordingly.

This acceptance is based on the information provided and remains dependent on continued compliance with the plan on site. Any changes to site activities, storage, layout or risk profile will require resubmission of an updated FPMP for approval.
