Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

You are non-compliant with your licence.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

A visit was carried out on the 30th October 2025 to the abstraction that takes place from the River Dee at Horseshoe falls under licence WA/067/0005/0030. A Canal and River Trust operative was on site at the time of the visit.

The reason for the visit was to ensure the correct screening was in place.

Condition 9.5 (i) of the licence stipulates:

For the period 1 May to 31 October in each year: No abstraction shall take place unless screens with 10 millimetre mesh are installed to prevent the entrapment, entrainment or impingement of salmon at the point of abstraction in accordance with the plans and specifications to be submitted and approved in writing by NRW.

The visit found that the screens were in place, with 2 of the screens being 10mm and the other 4 being 4mm screens. This is compliant with the licence screening condition for this time of year.

As a site operative was present, a check of the flow meter was carried out and found this to be showing 63.109 Ml/d. As this is a joint abstraction point with the United Utilities (UU) licence 24/67/5/0057, the combined daily maximum quantity for both licences is 86,925 cubic metres. 32,959 (CRT) + 50,006 (UU). The flow at the time was compliant with the quantity limits in the licence. A further audit will take place in the future on the annual quantity limits.
