## 4. Details of our assessment

On the 26th of February 2026, NRW officer attended ADVANCE FACTORIES STW LLANDUDNO JCN, permit CG0098501.

### Summary

During the site inspection, officers were unable to locate the outfall from the treatment plant due to excessive vegetation growth obstructing access and visibility.

### Permit Requirement

Under Condition 4 of the issued environmental permit, it is the operator's responsibility to ensure that both the location of the outfall and safe access to that location are maintained. This is required to allow Natural Resources Wales (NRW) officers to collect effluent samples in accordance with the permit conditions.

#### SAMPLING POINTS

4. The outlet to the watercourse shall be constructed and maintained so that a representative sample of the Discharge may be obtained at National Grid Reference SH 8085 7752 as shown marked 'Consent Point' on Plan CG0098501.

### Non-Compliance Identified

Failure to maintain accessible access to the outfall prevents sampling and constitutes a breach of permit Condition 4.

### Required Action

#### Action

The operator must ensure that suitable access to the outfall is provided and maintained, in accordance with Permit Condition 4, to enable NRW to take a sample when required.
