4. Details of our assessment

On the 9th of February 2026, NRW sampling officers visited Maduce Limited on Star Trading Estate, Ponthir to undertake final effluent discharge samples on the sewage disposal works serving the WC and canteen block (Permit no. AA0007601). On the 13th of February 2026 sample results were confirmed.

Breaches of permit condition:

Conditions imposed with respect to:-

(i) Nature of composition of discharge

(c) The effluent discharged to the stream shall not contain more than 30 parts per million of suspended solids, dried at 105°C

Justification

A sample was taken on the 9th of February 2026 as part of routine monitoring. On the 13th of February 2026 sample results confirm that the suspended solids, dried at 105°C was 36.5 milligrams per litre. The maximum Parameter limit is 30 milligrams per litre. This is a breach of 6.5 milligrams per litre.

Actions required by date specified

Investigate the cause of the permit limit breach.

Improve operations to bring the discharge into compliance with permitted limits.

The deadline for the above actions is the **9th of April 2026**.
