4. Details of our assessment

Routine site inspection of Dingestow Wastewater Treatment Works carried out by Environment Officer Peter Jones. Weather over cast and heavy showers.

Effluent enters works and enters primary tank, after settlement the effluent passes to a filter bed. The filter arm is rotating smoothly and there is no ponding evident on the filter bed medium, though there is some carry over of solids onto the medium.

Since, the last site inspection, a metal band and buttress has been fitted to the filter bed retaining wall to strengthen it. A rotation sensor has also been installed, if the filter bed arm fails to turn an alarm will activate.

The humus tanks are covered, the tanks looded to be operating effectively.

A visual check found the final effluent to be clear, no samples were taken during the inspection.

The site diary was up to date.

There are no follow up actions to be completed following this site inspection.
