## 4. Details of our assessment

On 4 February 2026, Natural Resources Wales (NRW) officers conducting business visits in the Llandudno Junction area attended the outfall at Jackson Stream, which serves the package treatment plant registered to Booker Belmont Wholesale Ltd (Permit: CG031390).

Upon arrival, officers observed a noticeable odour and visible fungal growth at the outfall. A formal sample was taken to investigate the matter further.

Laboratory analysis has now been completed. The results indicate an elevated level of Biochemical Oxygen Demand (BOD). The permit for this site specifies a BOD limit of 40 mg/l, whereas the returned sample measured 48.1 mg/l.

This constitutes a breach of Permit Condition 4, which requires the operator to comply with the numerical limits specified within the permit.

### **Required Action**

The operator must ensure full compliance with Permit Condition 4. NRW requests that the operator provides details of the actions taken, or to be taken, to prevent further occurrences of non-compliance.
