4. Details of our assessment

Notes taken during site visit

Final effluent appeared to run clear

At the inlet, there was grit build up. DCWW confirmed that the upstream network was to be inspected in order to identify potential causes.

The aeration ditch had build up of vegetation which should be removed.

Permit conditions; BOD 40 m/gl, SS 60 mg/l.

On site final effluent reading was 10.4l/s

Actions required by DCWW following site visit

- 1 Confirm FPF compliance, raw data not required, just confirmation of compliance
- 2 Confirm DWF compliance, raw data not required, just confirmation of compliance
- 3 Investigate and correct EDM monitor issue at the inlet.

Please respond by 3 November 2025

Further to your email of Friday 17 October 2025.

At the time of the audit, the DCWW representative stated that the sensor for the EDM to the storm tank was malfunctioning and not provided reliable data. As a result of this, we believed this could have a minor impact, hence the C3 score.

New deadline for response 10 November 2025

DCWW email received 14 November 2025

Update expected from the statutory maintenance team who are overseeing the work on the EDM for St Davids and will update you once we have got the full information.

They found the EDM monitor was unserviceable and therefore it was progressed to the EDM replacement programme 1st priority group. A survey was carried out on the 4th November to assess what equipment will be installed and planning. They estimated work will be completed by end of November.

Please confirm to NRW by the 5 December 2025 that the EDM monitor has been installed and running correctly.

Update received from DCWW 27 February 2026

Following further investigations, our operations team and EDM Maintenance team have now established a solution to complete the works needed to resolve this issue.

Due to several elements, it has taken longer than anticipated to establish the best way forward. As a result, we require until the end of April, whereby we will provide further update and evidence of our progress with best endeavours to complete sooner.
