Outstanding Water Abstraction Return

We have not received the required abstraction return(s) for licence number WA/067/0003/015 for the period 2019, 2020, 2021, 2022, 2023, and 2024. This is a breach of your licence conditions and is an offence under section 24(4)(b) of the Water Resources Act 1991.

Please ensure the outstanding returns is submitted by 03/06/2026.

We may also contact you by telephone to discuss the matter or arrange a site visit where necessary.
