Introduction

A site visit of the Conrad Energy Waunarlyydd Power Plant was arranged for 17th February 2026. Purpose of the visit was an assurance inspection of continued compliance with permit requirements.

Site Tour

The site consists of 27 natural gas fired engines producing electricity for the grid when required. Engines automatically engage to meet the demands of the grid.

Individual engines are located within a soundproofed and fully contained cab. Engines were not operational when the NRW officer arrived on site and they did not engage during the visit.

The operator is required to store coolant and engine lubricants on site for the maintenance of the engines. The required chemicals are stored within appropriate intermediate bulk containers (IBC) and oil tanks. Secondary containment is provided by IBC sub-pallet with tarpaulin rain guard.

The numerous spill kit stations located around the site were easily accessible and fully stocked with appropriate material in case of onsite emergency spills. IBC sub pallet bunds were visually inspected by NRW officer, all were found to be empty with attached rain covers providing adequate shelter.

Operator provided evidence of the site managers safety inspection checklist. Site manager performs monthly inspection of general site equipment including but not limited to alarm systems, drainage checks, bund capacity. In addition, the site manager also performs monthly electrical inspection of the assets on site.

Pest management systems in place, which are regularly inspected by pest control contractor. NRW officer did not observe any pests on site or have any concerns with the potential to attracting pest to the area.

Climate Change Risk assessment (CCRA)

NRW regulatory office has recently confirmed the adequacy of the operators CCRA following a light touch review.

Waste Records

NRW officer reviewed the operators waste consignment notes. Operator produces relatively minor volumes of waste material. Waste material produced by site include waste oil lubricants, contaminated absorbent rags, exhausted coolant and batteries.

NRW officer was satisfied with the series of consignment notes reviewed and their appropriate record keeping.

No non-compliance were recorded during this inspection. All observed activities were found to be in accordance with the conditions set out in the operator's environmental permit.
