4. Details of our assessment

Crugeran Poultry Unit was visited on Friday 27th February 2026.

Condition 1.1 - General Management

1.1.1 (a) - Risk assessments were present but not signed off by all relevant staff

Action: Ask staff to read through the risk assessments related to their roles and sign-off at the end to record they have understood by **10th April 2026**

1.1.1 (a) - Some maintenance records for the site were seen, such as electrical testing, but the site was missing any form of maintenance schedule, including planned preventative maintenance

Action: Create an annual or cycle maintenance schedule for the site, including preventative work such as checking the conveyor belt machinery and factoring down time for this by **10th April 2026**

1.3 Efficient use of raw materials

1.3.1 (b) - The site has a "carbon footprint" template to capture raw material usage for each cycle but this was missing some historical figures

Action: Complete the template with all required values for the current stock at the end of the cycle and keep this template up to date by **14th August 2026**

Summary

Overall the site was well maintained, with good control over pollution risks and multiple "green" initiatives such as rainwater collection and renewable energy sources. The non-conformances identified were minor, with little connection to pollution risks.
