### 4. Details of our assessment

#### Site Report

On 16th March 2026 Natural Resources Wales (NRW) Officers carried out a regulatory compliance visit for Environmental Permitting Regulations (2016) permit **AG0011101** that

permits Dwr Cymru Welsh Water (DCWW) to carry out a water discharge activity at Pontsarn wastewater treatment works.

The weather at the time of our visit was overcast with intermittent light showers. NRW Officers were escorted around the works by DCWW Pollution Prevention Technician (AGA) and Catchment Performance Manager.

No breaches of permit compliance were witnessed during our visit.
