## 4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced following a routine site inspection by NRW officers. The purpose of this visit was so the new inspecting officer could become familiar with site operations.

NRW officers were accompanied during the inspection by the HSE Co-Ordinator and the Mill Manager.

Officers were shown around the site, the plant and the vehicle washing area. The site was clean and tidy. Officers did not observe any issues related to dust, odour, noise or pests.

Officers noticed that several sheets of corrugated metal were missing from the housing around Intake 1 that was the result of a collision by a lorry accessing Intake 2. Although there did not appear to be any environmental impacts, the operator stated that the sheeting was due to be replaced imminently.

**Action Only 1:** Provide NRW with a completion date, in writing, for the replacement of the missing corrugated sheets by 31/03/26.
