4. Details of our assessment

On 28th February 2025, DCWW submitted Dry Weather Flow data for 2024, as required by the permit.

More than 14 consecutive days of the 366 daily volume readings were not 'Good' readings. This is a breach of permit condition 3.3.7(c) :

There shall be no more than 37 days and/or no more than 14 consecutive days with 'suspect' or 'missing' Total Daily Volumes in a calendar year, unless otherwise agreed in writing by the Natural Resources Wales.

It is noted that 2025 DWF data appears to be of similar quality. Previous information suggests this is due to power limitations. The poorer data appears to be in the winter. If this is a solar power related issue, consideration should be given to an improved power supply.

Action : please provide details of what improved power supply options are being considered e.g. increased solar power capacity.
