4. Details of our assessment

Site visited on 9 February 2026.

The works has a flow passed forward rate of 4 litres/sec, the operator believes this is being

consistently being achieved. 1.04 l/ps was observed during the visit.

Information received from DCWW data team 27/10/2025 relating to a previous site visit indicated that

The FPF has been assessed by comparing the pumped flow values against the CSO levels. Based on this evaluation, the site has broadly achieved a FPF of 4 l/s throughout 2024. It should be noted, however, that the monitors used are non-MCERT certified and therefore their accuracy cannot be guaranteed.

The padlock to the wet well had seized, this will need to be replaced before the next scheduled clean.

The permit has a limit of 5 spills per bathing season. NRW will contact the DCWW wastewater data team confirming if any spills have occurred during such time.

Email received from DCWW data team on 10 March 2026 indicated that there were four spills during the 2025 bathing water season.
