4. Details of our assessment

On 27 February 2026, NRW carried out a compliance inspection of the Afon Dwyfor abstraction authorised under licence 23-65-8-0016. Conditions 1, 2, 3, 5 and 7 were reviewed during the visit. All elements inspected were found to be in order.

During the inspection it was noted that on condition 9.1(ii)(b) the old Cwmystradllyn WTW are referenced. This should be updated through a licence variation to refer to the new Garndolbenmaen WTW for accuracy purposes.
