### 4. Details of our assessment

#### **Site Report**

Senior Environment Officer for Cwm Taf and Bridgend Environment Team attended site with DCWW Pollution Prevention Technician for Neath Port Talbot and Bridgend, and DCWW Network Engineer to carry out compliance inspections of Combined Sewer Overflows (CSOs). The weather was moderate to heavy rain.

This report is for the inspection of the asset permitted by permit number EPR/BB3896CW - Oakfield Terrace CSO, Nantymoel.

The improvement programme form submitted by DCWW states that there is no screening or storage provision at this asset, with the overflow weir setting at 2.75l/s. All storm overflows are subject to assessment in accordance with published GN066 guidance which will classify the performance of the asset. The classification will be used to plan and prioritise improvements to bring all storm overflows up to satisfactory status.

During the inspection of the asset I could not see it overflowing within the chamber (see image 1), however I was unable to inspect the outfall to the watercourse as we could not locate it at the point shown in Schedule 7 of the permit (see image 2). It is possible it was hidden by growth on the bank.

DCWWs storm overflow map shows that the Event Duration Monitoring (EDM) for this

asset recorded it last discharged on 20/10/2025 between 11:45 - 12:00.

It was noted at this location that there appeared to be a reasonably significant inflow from a surface water drain, believed to be the road drainage. In the future it is suggested that an assessment is carried out to determine whether it would be feasible to remove this input from the combined sewer.

### **Breaches of permit conditions**

- 2.2.1 *The discharge activity shall take place at the discharge point marked on the site plan at schedule 7 to this permit, and as listed in table S3.2. - Action only*

- Confirm location of discharge to watercourse - by **30/04/2026**
