Cwm Rhondda Waste Limited, Regulatory Site Inspection, Rhondda Cynon Taf (WP3797ED) 04/03/2025

Waste Regulation Officer Gareth Morris accompanied by Waste Regulation Officer; Marc Campbell and Carriers and Brookers Officer; Andrew Prestt visited the Cwm Rhondda Waste Limited Site, Albion Works, Dinas Isaf Road, Llantwit Fadre, Williamstown, Rhondda Cynon Taf, CF40 1NE on 04/03/2026 to conduct a routine site inspection and to assess compliance with environmental permit; WP3797ED

The operator holds a bespoke environmental permit (A13)

The site is registered as a waste transfer station that receives a number of waste streams.

Weather on day of inspection, was clear, dry with little wind.

On arrival at the permitted site, it was apparent that there has been no activity on the permitted site for a number of weeks. There was no waste on site, and the sites gates were locked. The site appeared to be non-operational.

I contacted the operator on 11/03/26 to request the status of the site. The site operator Mrs Susanne Trembarth informed me that the site was now non-operational and that she would be surrendering the site permit.

Due to the site being non- operational there are no permit conditions to assess against and therefore no permit actions or breaches to be recorded.

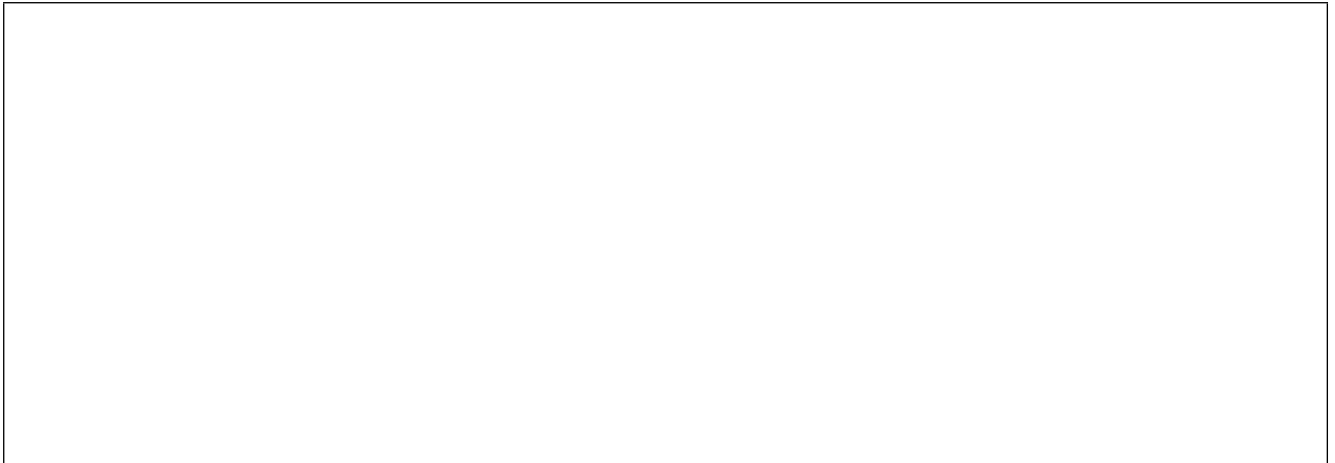
