4. Details of our assessment

On the 27th of February 2026 Dwr Cymru notified Natural Resources Wales of a permit exceedance at Froncysyllte Wastewater Treatment Works.

On the 20th of February 2026 Suspended Solids was recorded at 78mg/l against the regulations limit

of 60mg/l.

This site benefits from the look up table procedure which allows a number of exceedances before and absolute failure is recorded. This is the 2rd exceedance for Suspended Solids at this site within the last 12 month period. This result has been recorded as an exceedance.

DCWW confirmed that they experienced no operational issues on the day of the sample, there was rainfall in the area and the treatment works saw flows up to 7 l/s when FPF is 4.4 l/s. DCWW believe the additional flow may have reduced settlement time and cause the deterioration in the sample.
