4. Details of our assessment

This Compliance Assessment Report is being produced following a routine site inspection, conducted by Luke Taylor (Senior Officer - Waste Regulation) and Alder Tye (Waste Regulation Officer) of Natural Resources Wales.

The weather at the time of the inspection was grey and overcast. The officers were accompanied throughout by the site operator and Technically Competent Manager (TCM), Lindley Evans. The site was operational at the time of the inspection.

W1A General Management - Permit Condition 1.1.4

The continued competency qualification of Lindley Evans is in date and covers the activities being undertaken on site.

Attendance of the TCM is being recorded in the site diary as required.

W2C Operating Techniques - Permit Condition 2.3.1 - Category 3 Breach

You have been scored a category 3 breach for the above permit condition as the area of impermeable surface within the transfer building has failed, with cracks allowing fluids to pass through.

The transfer building contains food waste and residual waste, amongst other waste streams, and run off from these was seen to be flowing into the cracked area of impermeable surface.



Permit Condition 2.3.1 (a) states that the activities shall, subject to the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in schedule 1, table S1.2.

Table S1.2 states that uncontaminated ferrous metal wastes or alloys and uncontaminated non-ferrous metal wastes, untreated wood and inert wastes shall be stored on hardstanding or an impermeable surface. All other wastes will be stored on an impermeable surface with sealed drainage.

**ACTION - Repair the area of impermeable surface within the transfer building.
Deadline - 31/05/2026**

W3B Emissions of substances not controlled by emission limits - Permit Condition 3.1.1

There was no evidence of debris on the carriageway leaving the site and no evidence of waste escaping the site at the time of the inspection.

W4B Reporting - Permit Condition 4.2.2

The waste returns for the site have been submitted as required, with the next returns for Q1 of 2026 being due by 30th April 2026.
