4. Details of our assessment

Langdon WWTW was visited 12 February 2026

Daily site visits are undertaken by the operator

Site is subject to a daily manual de sludge

The permit indicates a flow passed forward of 24.3 l/s. The operator is aware that this is not being met.

What is the plan for the site going forward and in particular addressing the infiltration issue ?

NRW was unable to view the settled storm discharge point at the time of the visit owing to overgrowth. The operator will address this and a future visit will be arranged

Is there a plan for the aeration lane to be upgraded/repaired? It was noted that some repair is needed and that the liner was being held in place by grappling irons.

Final effluent discharge point at Langdon bridge SN09075701 was viewed and appeared clear.
