4. Details of our assessment

Site Report

Senior Environment Officer for Cwm Taf and Bridgend Environment Team attended site with DCWW Pollution Prevention Technician for Neath Port Talbot and Bridgend, and DCWW Network Engineer to carry out compliance inspections of Combined Sewer Overflows (CSOs). The weather was moderate to heavy rain.

This report is for the inspection of the asset permitted by permit number BW3206601 - Ogwr Fawr CSO Ogmores Vale, St Johns street.

During the inspection of the asset I could not see it discharging, and there was no visible sign of fungus or grey staining around the outfall, however there was a small amount of sewage litter in the vegetation in the immediate location of the outfall. The discharge is via a pipe in the chamber wall (see image 1 below), which then discharges via a pipe in a wall (see image 2).

During the inspection I could not confirm the presence of a screen as detailed in permit condition 2.3 and table S3.3 in schedule 3.

At the time of writing this report, there is no display of EDM data for this asset on the DCWW Storm Overflow map, so it is not possible to determine when this asset last spilled.

All storm overflows are subject to assessment in accordance with published GN066 guidance which will classify the performance of the asset. The classification will be used to plan and prioritise improvements to bring all storm overflows up to satisfactory status.

Breaches in permit conditions

- 2.3.1 For the discharge specified in table S3.3:
 - (b) The discharge shall not be comminuted or macerated and shall have passed through screens as specified and shall not contain a significant quantity of solid matter with a particle size greater than any indicated. All screenings shall be removed from the discharge. - This has been assigned a category of action only for DCWW to confirm the presence of the screen. If there is no screen installed the categorisation of this non-compliance will be revised.
