4. Details of our assessment

Meadow House Holiday Park was visited on 16 March 2026.

The site has been under new ownership since the latter part of 2025.

Meadow House operates for ten months per year, namely, March to December inclusive.

The tank was emptied in November 2025 and a de sludge of the system is proposed in late spring 2026.

According to the permit, the operator is required to retain maintenance/service records for at least six years from the date when the records were made.

The site appeared in good working order with no issues apparent.
