4. Details of our assessment

Natural Resources Wales Senior Industry Regulation Officer Ricky Hartleb and Lead Specialist Officer Phil Harper visited Bimeda of 23/24 Colomendy Industrial Estate, Denbigh, LL16 5TA at 11:00 am on Friday 13 March 2026, as part of an arranged site familiarisation / compliance visit.

The visit was accompanied by the General Manager and the QA Manager. The site engineer introduced the emission abatement system for the site.

At the time of the visit the site was operational.

IR1A General Management

A briefing was provided outlining site operations and proposed improvements to utility efficiency.

The management demonstrated good operational knowledge and awareness of regulatory obligations.

No compliance concerns were identified

IR2A Permitted Activities

The site was clean and operating within its permitted activities. Waste was stored correctly in designated areas.

No compliance concerns were identified.

IR2B The site

The operator outlined their ongoing plans for improvements related to the sustainable management of natural resources.

No compliance concerns were identified.

IR4A Records

A sample of operational and environmental records were reviewed. All records inspected were complete, accurate and appropriately maintained.

No compliance issues were identified.

The visit identified no non-compliances, and the site appears to be operating in accordance with the conditions of their permit.
