This compliance assessment report covers a site visit to Curvolt on 23rd February 2026, following the recent transfer of permit EPR-BJ6968IY.

The site visit included a tour of the site and a discussion regarding plans for the site and reporting requirements of the permit.

The reactors previously used on this site by IQE Silicon have been removed and Curvolt have not yet installed their intended reactors. IQE were advised that a permit variation is likely to be necessary to ensure that the activities and operating conditions on the permit are not breached and that any new activities are included in the permit.

Curvolt were advised to ensure that the reporting requirements of the permit are maintained.
