4. Details of our assessment

This Compliance Assessment Report follows an unannounced inspection of the site on the 23 February 2026 following numerous odour complaints received by NRW on 22 February 2026. Further complaints were received on the day of the inspection and whilst officers were on site.

Prior to attending site, officers visited several locations within Chirk and detected a strong offsite odour. This included a MDF odour and a wet wood odour. The weather was dry, breezy with a westerly wind. The odour was identified to be from the MDF cyclone and WESP plumes grounding over Chirk.

Officers attended site and met with the Operations Director and Environmental Manager. It was noted on arrival that the MDF cyclone plumes were grounding within the car park.

Various processes and equipment were visited to assess whether there were any issues that may have contributed to the odour noted within Chirk. Officers viewed various process screens and spoke with staff, no unusual incidents or events had been recorded over the weekend. Both MDF lines and the particleboard line had been down for short periods over the weekend. All abatement was operational and dosing of the WESPs was occurring at the time of the visit. The K8 boiler was operational.

The K7 boiler was off following the conclusion of the monitoring undertaken as part of the Regulation 37 Suspension notice issued to the Operator on 8 January 2026. Officers visited the K7 bunker and the boiler control room to confirm this.

Further reviews of abatement techniques will be undertaken and assessed on future visits.
