4. Details of our assessment

This Compliance Assessment Report follows unannounced inspections of the site on the 9 March 2026 and 13 March 2026.

09 March 2026 10:10 - 11:10

Officers completed an unannounced site inspection and were met at Reception by the Production Director.

Officers were escorted through the MDF plant and were met halfway by the Operations Director. Officers initially went through to the 'walking floor' underneath the K7 boiler to inspect the boiler fuel feedstock ready to be fed in. Visually the fuel was clean and uncontaminated.

On arrival in the Control Room, officers requested to see the historic data of the start up temperatures beginning on Saturday morning (07/03/2026). The data showed a steady rise in boiler temperature over the weekend.

Officers then visited the logyard and were met by the Logyard Manager who explained the new process for ensuring boiler feedstock is not contaminated by pallet banding etc when rejected flooring is crushed. The feedstock showed no signs of contamination.

While walking back to Reception, officers spoke with the Environment Manager about skip management on site (multiple MDF skips across the site feed the boiler feedstock). Additional training has reportedly been implemented by the Operator to ensure the correct waste is being placed in the correct skips.

13 March 2026 14:15 - 15:30

Following a number of odour complaints received during the morning, officers visited Chirk prior to the unannounced site inspection. The MDF1 cyclone plume was grounding to the north east of the site. There was also a noticeable odour from Mondelez.

Officers were met by the Operations Director. No unusual incidents or events had been recorded and the operator attributed the odour to plume grounding from the MDF cyclones.

The MDF2 line was off at the time of the visit. No other process issues were identified.

The K7 and K8 boilers were operational. Officers visited the Boiler control room, checked the fuel in the K7 fuel bunker, visited the log yard to review shredding operations for any contamination and inspected the IBA. The previous K7 stockpile was being sorted. No issues were identified.

The Operator confirmed that the MCERTs test house would be on site the following week

undertaking emissions monitoring from the K7 biomass boiler and MDF2 cyclones as required by the Regulation 36 notice issued on the 5 March 2026.
