## 4. Details of our assessment

**The purpose of report is to assess and record compliance with condition 3.1 Emissions to Water, relating to Event Duration Monitoring and a Trigger Exceedance Notification.**

Permit version in effect - **11/08/2022**

On **1 October 2025**, Natural Resources Wales (NRW) received a Trigger Exceedance Notification (TEN) for CSO 104, Newbridge Road Pumping Station (BB4025501).

The Ten informed us that on the **4 September 2024** the permitted spill frequency had been exceed. As outlined in Table S3.1 of the permit the asset is permitted to spill (block-counted spill) 5 times between 15th May and 30th September (inclusive).

A compliance assessment has been undertaken of relevant conditions of permit

3.1.2 ... If the measured number of significant block counted spills exceeds the limit specified in Table S3.1 this constitutes a Trigger Exceedance and the operator shall: (a) notify Natural Resources Wales of the Trigger Exceedance as soon as reasonably practicable (and no later than 4 weeks from the date of the Trigger Exceedance) in a format agreed by Natural Resources Wales;

**The TEN was received within the permitted period and in the agreed format, therefore you are compliant with this condition**

The document was **not received** within the conditioned period relevant to the TEN received on the **1 October 2025** therefore you are **non-compliant** with the said condition above.
