4. Details of our assessment

On Friday the 6th of March 2026 Natural Resources Wales officers attended the site.

This was an unannounced, routine inspection.

The site was last visited by Natural Resources Wales the 6th September 2024, the previous inspection is detailed in Compliance Assessment Report: [CAR_NRW0045204](#).

The site was open with operatives performing their duties. The weather was wet and windy.

On arrival officers met with Charles Whyte, site manager, who accompanied officers during the inspection. Officers were asked to sign in.

The inspection started with a conversation in the manager's office to discuss the activities on site and any changes since the last inspection. Mr Whyte's manager was also present.

Fire prevention measures

The site benefits from four interceptors, each has capacity of 35.000 litres.

The site has a discharge point and a possibility to block the interceptor completely in an emergency situation (i.e. fire).

The discharge point is inspected on a regular basis. Officers checked the latest inspections' records. All relevant information and photographic evidence was in order.

Consignment notes

Officers asked to see most recent consignment notes and requested copies for a waste audit.

The notes have since been received, assessed and a waste audit report form has been sent to the site manager.

Depollution area

Officers then walked round the site and inspected the depollution area which looked well organised and tidy. The vehicles are not being fully depolluted on site but when necessity arises batteries and other components are being removed. Officers saw batteries in appropriate, acid-proof boxes, stored inside this area.

Spill granules and spill kits were also readily available in this area in case of any leaks or spills.

Vehicle storage

The vehicles are being stored on impermeable ground with fire breaks between petrol or diesel cars and extended fire breaks between electric vehicles.

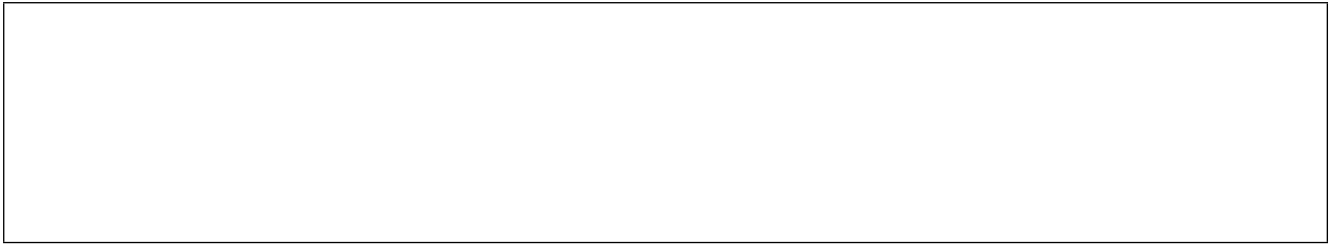
