## 4. Details of our assessment

**This report details the site visit made on the 17 March 2026 to Caerphilly County Borough Council, Coed Top Hill - permit reference number EPR-DP3095FK.**

Natural Resources Wales (NRW) Officers Carla CURTIS, Cerys PHILLIPS & Anna ANDREWS attended site at 11.15 to conduct an unannounced routine inspection. Weather conditions were sunny and warm at the time of inspection. They were met by the site supervisor who accompanied officers around the site to assess the site for any compliance issues and to visually understand how the dewatering system operates. Site operations consist of municipal street cleaning and gully waste dewatering facility with biological treatment via reed beds.

### SITE OBSERVATIONS

In terms of the current on-site operations, the facility was running efficiently in accordance with the specified activities. NRW Officers did not witness any offensive odours or excessive noise emanating from the permitted area during the inspection. The yard area nearest to the site office was in good order. The storage bays appeared to be in good condition with the drainage channels free of obstructions. The current stockpile was within permitted limits and of no concern. The integrity of the drying bays was free of cracks and show no signs of degradation.
