### 4. Details of our assessment

This Compliance Assessment Report is being produced following a routine inspection of Cilmaenllwyd Household Waste Recycling Centre. The inspection was conducted by Luke Taylor (Senior Officer - Waste Regulation) and Alder Tye (Waste Regulation Officer).

The weather at the time of the inspection was dry and overcast and the officers were accompanied throughout by the site supervisor.

The site was in operation at the time of the inspection.

During the inspection the officers assessed the storage and handling of waste being deposited by householders. Waste was being segregated as required, with staff checking to ensure compliance by those using the site.

The site diary was checked and showed regular attendance by the site TCM, Lindley EVANS, and his continued competency qualification is up to date for the activities being undertaken on site.

**W1A General Management - Permit Condition 1.1.1 - Action Only**

The above condition states that activities must be undertaken in accordance with the limitations in table 1.1 'Specified waste management operations'. This states that waste shall only be stored within designated skips, drums and tanks upon an impermeable pavement.

The skips used to store waste televisions were all full, and any further sets brought to site would have to have been refused, as accepting would have resulted in the waste being deposited on the ground and not a skip.

**ACTION - Please ensure that waste television skips are emptied at regular intervals so that waste can continue to be accepted.**

There was no evidence of any waste escaping the site boundary, the carriageway outside the site was clear of any debris and there was no evidence of odour off site.

The waste returns for the site have been submitted on time as required.
