4. Details of our assessment

This inspection of Gerald D Harries & Sons Ltd site drainage serving Llandarcy Asphalt Plant was undertaken as part of our compliance programme.

Permit version in effect - 29/07/2024.

At the time of the inspection the weather was dry with no discharge occurring.

Observations & Actions

Officers observed oil contamination to the ground within the swale at the outfall of the lower aco site drainage. As discussed with the operator, this may well be due to the activity of loading lorries having oil (diesel) in the bed of the tipper to prevent the material from sticking and not the material itself. We are concerned that this is causing oil contamination to ground as can be evident in the photograph below.

**Action**

Please provide information regarding the temporary clean up and long term solution in place to prevent this reoccurrence of contamination.

Pease provide details regarding the construction of the swale.

No oil residue was present lower down at the top end of lower swale.



It was observed running along the boundary of the lower swale that there is little to no barrier to prevent run off from various stored aggregates. We are concerned that contaminated material may deposit into the channel via run off.

Action

Please provide a site plan which includes the drainage system for this area. It is important that all site drainage is directed through the interceptor before being discharged into the environment.



Stone was observed to be covering the sampling chamber and had to be removed by the operator.



You may wish to clearly label the location of the sampling chamber for availability and easy access.
