#### 4. Details of our assessment

A routine sample taken at Knowles Farm, Lawrenny (Station number 89310) on 18 August 2025 failed for Ammoniacal Nitrogen as N. The result value returned was 12 mg/l against a permit limit of 5 mg/l.

You notified us in January 2025 of your intention to replace the sludge recycling pump.

Please inform NRW if the upgrade has taken place and provide the reasoning for the sample failure in August 2025

##### **Deadline for response 31 October 2025**

Email received from Operator 31 October 2025, stated that, the sludge recycling pump had been reset with the system is being regularly desludged.

This email also confirmed that the Operator is looking to replace the system and update the permit. No time frame has been identified.

##### **Please can you provide an expected timeline for this replacement by the 31 December 2025**

##### **5 January 2026 - An update on the current situation is overdue**

During a Teams call on Friday 20 March 2026.

The Operator indicated the following:

*'Just to confirm regarding the outstanding CAR we are continuing our regular desludging to manage the system outputs while the plant operates below effectiveness.*

*We have updated NRW on the pending development at Lawrenny with regard to renewing the system and doing other remedial work on the network to reduce surface water ingress.'*
