4. Details of our assessment

On 11 March myself and Kirsty Allwood attended Plas Pencelli on an un-announced inspection following a sampling issue from an NRW sampling colleague. The weather was mild and sunny.

On arrival we made ourselves known to reception and were shown the system by a member of staff - thank you for your time during the inspection. This site all flows to a Rotating Biological Contactor, we did not look inside but appeared to be operating as designed. There was a knocking noise from the RBC that had been noted by staff previously and a service had already been booked with a contractor. The site appeared to be functional but ageing, the sampling manhole at the rear of the RBC needs maintenance to ensure it's accessible for sampling as per the permit.

ACTION: Ensure the sampling point is clear and accessible at all times for sampling purposes as per Permit Condition 3.

We then checked on the outfall that was flowing relatively clear at the time but appears to have been affected by higher river flows and erosion, but was accessible and suitable at the time of inspection (but may be less so during high-flows). The site is managed by an external contractor on a routine basis, details of this were offered if required, and is emptied typically twice a year ahead of the busier periods. The site appears to be otherwise compliant.
