4. Details of our assessment

On 11/03/26, NRW officers visited Aberglasney Gardens to collect a routine effluent sample from the package treatment plant serving the site. The sample was found to contain 6.47mg/l Ammoniacal nitrogen against a permit limit of 5mg/l.

This result is a permit breach and is scored accordingly.
